# The Shropshire Parent and Carer Council (PACC)

PACC is the parent carer forum for Shropshire. Our core aim is ensuring that the voice of parent carers informs and influences local, regional and national decision making related to Special Educational Needs and Disability policy and services.

PACC provides representation for families of children and young people aged 0-25 years, who identify themselves as SEND families in Shropshire. Our core funding is provided through an annual participation grant from the Department For Education, we have also secured funding this year from Shropshire Council, Shropshire CCG, Learning Disability England and the Pears Foundation Trust. PACC is a registered charity.

A key principle of PACC's work is that it is experience led and so all PACC's trustees and operational leads are themselves parent carers, who work closely with the Shropshire parent carer community to inform their work.

PACC's focus is on creating an environment that supports co-production, working in a solution focused way, to enable improved outcomes to be achieved for everyone.

An important element of PACC's work is supporting information provision to the Shropshire SEND community, ensuring that parent carers are able to make informed decisions and understand what support is available for SEND families.

As we learnt to live with Covid, and we started to come together as a community again PACC have continued to offer the chance for SEND families to meet up and benefit from peer support.

## **Actio Consortium**

PACC continues to support the development of the Actio Consortium and the increase of inclusive, community-based activities for children and young people with SEND. We are in the second year of the managing the All In scheme on behalf of Shropshire Council and are very please with the increase in members from just over 200 families to over 700 families. Over the summer of 2021 PACC secured additional funding of £10k to be able to offer a summer programmed aimed at supporting families to re engage in community activities after lockdown. The summer programme was very well received

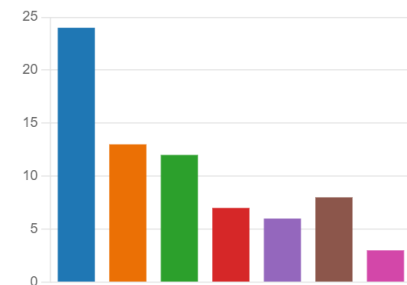
As previously parent carers told us that Facebook is an important delivery mechanism for information, along with the PACC newsletter and direct mailouts.



Following the publication of PACC's 'A Sense of Purpose and a Home of my Own' report in February 2020, PACC has been working with Shropshire Adult Social Care to respond to the key points raised by the report 'A Sense of Purpose & a Home of My Own'.

One of the issues raised by the report was the lack of information available to families about Supported Living; what it is, the process involved and how those in Supported Living are enabled to lead active lives. This workshop will provide an introduction to Supported Living, the process to access it and information about what life might look like for young people in Supported Living.

The session will be targeted at parent carers of young people aged 16 - 25, who are considering a move into supported living at some point in the future. Members of the Adult Social Care Team will join us and there will be a lunch and chat at the end of the workshop for those who would like to stay.

While this was not identified as a significant area of weakness in the Shropshire SEND Inspection, opportunities for improvement were noted and it is an area which families tell us is of particular importance to them. PFA is also central to the Shropshire SEND Strategy published April 21

After publishing our report 'A Sense of Purpose & A Home of My Own' detailing families experience and thoughts on PFA in Shropshire, PACC working with Shropshire Adult Social Care hosted a Supported Living conference in Nov 2021. The conference aim was:

*'To respond to the findings of the 'A Sense of Purpose and Home of my Own Report', so that parent carers are more confident about what Supported Living is, the process and how to ensure that young people in supported living lead good lives.'*

The conference was very well attended with 50 participants and feedback was positive with many parent carers saying they would like more opportunities to discuss this topic. The feedback from the facilitated discussions which were part of the events programme has informed PACC's PFA activity going forward, in particular the development of the PFA Navigator Project.

# Chair's Report

Last year I closed the chairs report with the statement:

**“...you are the ones making the real difference. Without your feedback, experiences, and critical eyes, we would have very little to share with the LA and CCG on your behalf. You are the heart and soul of PACC. “**

Well, this year we have most certainly felt your influence in our work stronger than ever. Our Parent Carer community have contributed to, and influenced, 11 participation opportunities, 2 learning events, and we provided 11 key communications to update and inform families of our ongoing activities alongside our usual updates and news articles.

We coproduced a bespoke program of activity for children and young people that provided activities and opportunities for those up to the age of 25 as part of our work within the Actio Consortium, and a filming and production opportunity in partnership with The Hive.

Parent Carers shared their experiences and aspirations for speech language and communication services, neurodevelopmental pathway, adult social care services, and most importantly fed into our Mad Sad Glad survey.

As always, we are humbled by the honesty with which you engage with us. Our Mad Sad Glad survey demonstrated the challenges you face, and the sadness these bring to our communities lives every day. We were devastated to hear of some of the things that make families Sad and frustrated to hear that little impact is being felt by the work we participate in as a strategic partner in the SEND system. The themes we picked up running through the Mad section of the survey did not come as a surprise to us, but we were again frustrated that families are still feeling let down and unsupported, particularly around the neurodevelopmental pathway and mental health support for their children.



*So, while we hear about, and provide opportunities for you to share, your experiences, what do we do with them?*

*As always every experience shared with us informs conversations, we have with local area services or commissioners. It helps us coproduce changes and solutions that, we hope, better reflect the needs of the community. And we have a greater understanding of the needs of the SEND community and Parent Carers as a result.*

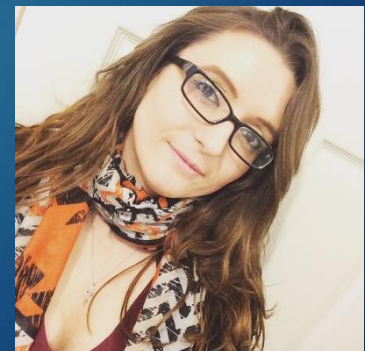
*Already, following the publication of our Mad Sad Glad Report, the Shropshire Carers Service has been instructed to explore and coproduce a clear and improved carers service offer for Parent Carers of children and young people with SEND, under the oversight of the Joint Commissioning working group. The Integrated Care System asked us to deliver a 'key points' presentation via a recorded message shared with them to bring the key themes to their attention. The Director for People and Assistant Director for Education and Achievement at Shropshire Council have ensured all Senior Leaders and Service Managers across education and social care were made aware of the report and our recommendations. We feel it has made an impact in the right ways, but it was certainly a difficult read for many. However, families also shared what made them Glad, and some of these comments have inspired us in PACC, as well as strategic leads in the SEND system, to strive to be better still and aspire to have a greater impact on your lives.*

*As always, I reflect on a year of activity that has kept our Strategic Leads busy, maintained your voice within key conversations ensuring your experiences influence change locally, and a year that has challenged us immensely. Our team of leads, volunteers, our wider community partners, and the SEND Parent Carer community have made a difference this year. In the period April 21 – March 2022 PACC secured the following funding;

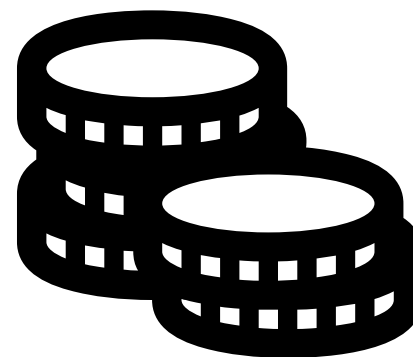
**Dept For Education** – Core funding of £17500

I am a 46-year-old father to 7 children ranging in age from 22 years to 4 months old.

Due to a works injury just over 10 years ago I was physically injured meaning despite years of trying I was unable to work.

Whilst we are lucky that we have a family setting it is not what most people would call normal .... whatever normal is?

My first understanding of a child with additional needs was having a brother with ADHD as a teen, more recently my connection is down to my cheeky cute 5yr old Son who is a pupil at Severndale.Academy and has a diagnosis of ASD & severe learning disabilities.

Like most parent carers I think we do what we can to support our children regardless of age, whenever they need it whilst trying not to go mad trying to access the services we are all told are available to us.

My interest in becoming a PACC trustee is down to the personal support and advice I have received from the PACC as well as the memories of the mind-numbing amount of red tape and repetition it takes to get support from the correct teams and believing there has to be a better way via PACC & Co Producing.

I personally have had to fight and do far too much self-researching to get the help and support for my Son and Family and have experienced the stress and frustration in getting the basics such as OT and Social Services allocated.

If I am appointed as a Trustee, I would be willing to not only attend required meetings but to undertake any additional workshops or work to aid and improve my understanding of the work of the PACC to ensure I repay the trust put in me.

# New Trustee Elections

## ► Ruth Minshall

I'm Ruth, 48, and parent to a very special 11 year old named Jacob. I've been a single Mum since Jacob was 9 months old. At aged 3, Jacob was officially diagnosed with Autistic Spectrum Disorder and Severe Learning Disability in Communication and Social Interaction. It's just been me and him and we've been on our journey together. I was a previous Parent Rep for PACC but as Jacob grew older I needed to devote more of my time and energy to him. Unfortunately along the way, it became apparent that Jacob had very complex needs including ADHD, Severe Anxiety, erratic sleep patterns and behaviour that challenges to name but a few.... We have worked with various health and social care services over the years and Jacob was previously schooled at Severndale. It has given me first hand experience of the support services available and I hope to be able to contribute with my experience to help inform future planning to support other Parent Carers. Jacob and I have had some significant changes in the last 18 months and he is now a very happy (on the whole) and well supported young person at Overley Hall School on a residential placement. He copes far better with the World around him with minimising transitions and wrap around consistent support. However after a period of quite difficult adjustment personally, I now have time to work with PACC again and look forward to the opportunity.
