Terms of Reference

Purpose

- To work collaboratively on reviewing processes, provision and services for Shropshire children and young people with special educational needs and / or disabilities to ensure positive outcomes and best value.
- To provide regular reports and recommendations to SEND 0 25 Strategic Board so that the board can monitor the delivery of the strategy for children and young people with special educational needs and/or disabilities.
- To provide input into the SEN Annual Report

Principles

- To work collaboratively as a partnership in order to evidence positive outcomes and support the establishment of best value services and provision across the 0 25 age range
- To ensure that:
 - children and young people with SEND and their parents and carers are provided with opportunities to participate in and/or co-produce the development strategy, policy/protocol and services and are given appropriate opportunities to provide feedback about SEND services, provision and strategies
 - feedback is used to inform the SEND Strategic Board to support the review of and to develop provision for SEND across the local area
 - o partners understand the needs of children, young people and their parents and carers
 - o provision meets the needs of children, young people, parents and carers
 - o personalisation underpins everything that we do
 - budgets are used effectively and efficiently

Key Outcomes (deliverables)

The QPF group will support the development of the SEND strategy action plan, inform self-evaluation and ensure effective preparation for inspection through:


- ✓ Development of performance measures and establishing data sets to:
 - measure the success of the local area in implementing the Children and Families Act and Care Act
 - o support the development of the JSNA in order to inform the commissioning process and service provision across the local area for SEND 0 25.
- ✓ Establishing key performance indicators for each agency to create an electronic dashboard so that key performance criteria and impact can be shared (to be accessible on the LO).
- ✓ Identifying existing opportunities across all agencies to quality assure process and provision and to identify gaps. This will facilitate appropriate support and challenge and identify training needs.
- ✓ Collate supporting policies and procedures and identify gaps.
- ✓ Collate and review training opportunities with regard to SEND and evidence the impact of training undertaken.

- ✓ Analyse feedback and complaints to inform future practice
- ✓ Establish an overarching budget monitoring system

Accountability and Responsibility

- The SEND QPF working group will provide regular reports on progress towards outcomes to the SEND 0 – 25 Strategic group.
- The Chair/s of the QPF group will sit on the SENCD 0 25 Strategic Board.
- The QPF chairs will ensure:
 - o active contribution to meeting outcomes
 - effective communication on information from QPF to SEND 0 25 Strategic Board is in place as a two way conduit for information on SEND 0 - 25 Strategy
 - that they contribute to the regular work stream chairs meetings
